Statement of scope

« Law and Economics » is a book series published by one of the leading European law publishers, the Editions BRUYLANT (Brussels). The objective of the series is to publish valuable, original contributions to the study of the relationships between law and economics and to the dialogue between the two disciplines. These contributions can be theoretical, methodological, or empirical. The series' editors consider with considerable interests book proposals that develop a comparativist perspective as well as proposals dedicated to the history of legal and economic thought.

The books can take the form of individual volumes as well as a collection of original articles. In the latter case, the editor should be attentive to its general consistency and to the complementarity of the individual contributions. Proposals for book projects based a doctorate thesis are welcome.

While priority is given to French books, books written in other languages will also be published.

Call for authors

Proposals can take two forms:

- A book project: the author or editor should submit a brief prospectus (5-6 pages) which must include: (a) the prospective title of the book; (b) a description of the project (subject, organizing theme, potential authors); (c) a table of contents, (d) an overview of the prospective contribution of the book to the dialogue between the Law and Economics.

- Completed manuscript. The author or editor is invited to send a draft manuscript and to submit a brief prospectus (5-6 pages) which must include: (a) the prospective title of the book; (b) a description of the project (subject, organizing theme, authors); (c) an overview of the prospective contribution of the book to the dialogue between the Law and Economics.

Book projects or manuscript proposals must be sent by electronic mail to the series editors. The projects and proposals will be examined by the scientific committee.
